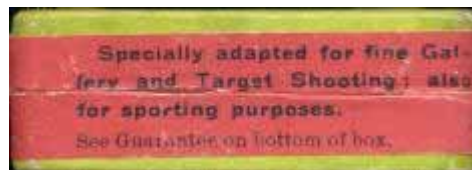
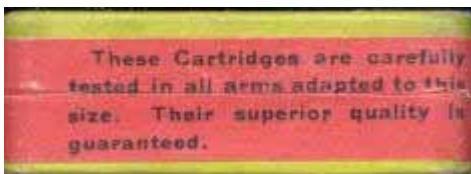
Remington Arms—Union Metallic Cartridge Co.

In 1911, Remington combined two great names, Remington and the Union Metallic Cartridge Co. The first issues of this combined marketing effort featured the logos of the two companies separate on the top labels.

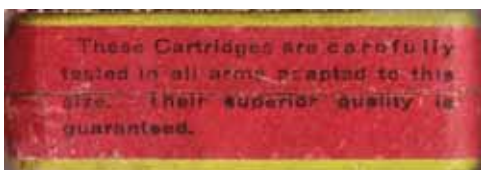
The REM-1 boxes are split logo boxes. A split logo box is defined as a box that has UMC on one side and Remington on the other side of the top label. Date codes on these boxes show that they were made from 1911 to 1913. All boxes are two-piece half-split construction with paste on labels.



- S-1 A .22 SHORT. “BLACK POWDER”. Red label with and white printing. Green, two-piece, half-split-box. Red side sealing label. No product code. "U-3" h/s on a copper case. Lead bullet. “BLACK POWDER” on end.

1911—1922

Section two lists the combined logo boxes. These pages are labeled REM-2. A combined logo box has REMINGTON over UMC in a red ball on the top label on the box. The early combined logo boxes have the UMC letters much larger than the REMINGTON. The boxes with the large UMC letters have date codes from 1911 to late 1914. The 1913 REM-UMC calendar has this style of logo. Date codes have been found on the later REM-2 boxes from 1914 to 1922. The REM-2 boxes outnumber all of the other Remington boxes in the checklist combined. All the REM-2 boxes are two-piece half-split construction with paste on labels.

In 1926, Remington introduced their new non-corrosive priming system. This aided in the preventing of rusting of the barrel bores, which was a major problem prior to this invention. They run a contest with a \$500 prize to the person who named this issue. They introduced a new box style with this issue, which to most collectors is known as the DOGBONE KLEANBORE issues. This box style remained in the product line until at least 1937, however the box had many minor changes during the years.

This section will be divided into 5 parts to reflect the bullet finishes and high velocity and standard velocity loadings. The first section is used to catalog the box bottoms, sides and end flaps bottoms, sides and end flaps that are noted in these various issues.

In 1930, Remington introduced their high speed loadings. Along with this development of the high speed issues, a new bullet finish was placed on the market, which they named Silvadry. Because not all shooters wanted high speed ammunition, nor all guns able to shoot cartridges with the higher pressures, The older standard velocity ammunition had to be retained. The standard loads were available in both lead lubricated bullets as well as the Silvadry finish. Thus 4 different issues were available at the same time, standard velocity and high speed and both in lead lubricated and Silvadry bullet finishes. Each of these issues will be cataloged separately.

The old style dogbone logo box was retained, but now is marked as to the type of bullet finish and if a high speed loadings. New product codes helped to callout the bullet type. This style of box was replaced for the most part by the 1936 Kleankote issues, but some of these boxes were available until the 1940s. The Pat. Off. data is not generally noted in the logo of these issues.

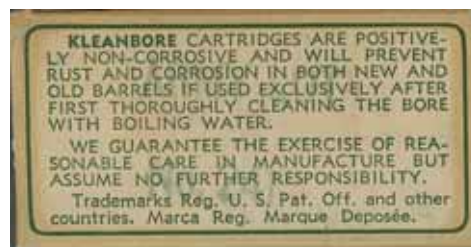

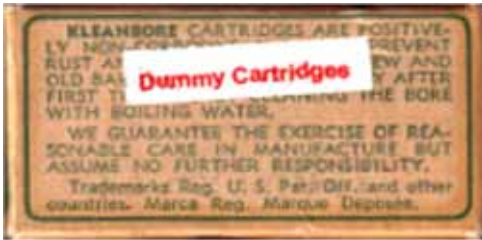

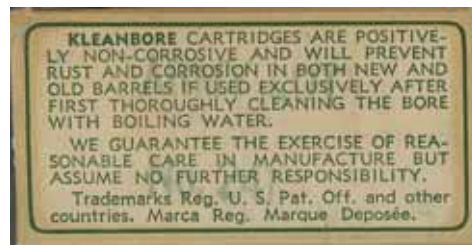

## 1931 "KLEANBORE SILVADRY"

In 1931, Remington introduced their new high velocity loading. This was coupled with a new dry bullet finish, which they named Silvadry. This was their answer to the Kopperklads of Winchester, the Lubaloys of Western and the Gildkotes of Peters. However this type of dry finish was never pushed by Remington. They only introduced it to remain competitive with the rest of the .22 manufacturers of that time.

Due to the fact that some of the older guns could not handle the pressures involved in high speed ammunition, the older, standard velocity loadings were retained in the product line in both lead lubricated bullets and the new Silvadry finish. This is the second listing in a series of 4 of the 1930 issues. The Silvadry finishes never sold well, and the standard velocity loadings are very difficult to locate. This issue was dropped from the product line sometime about 1936.

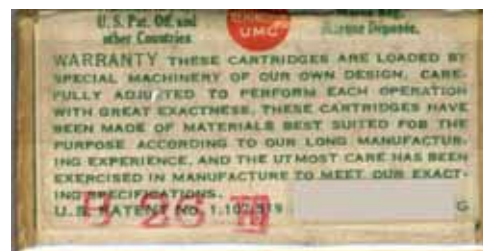

In 1930, Remington introduced their high velocity loadings which they named HI-SPEED. This high pressure cartridge required the use of brass cases in place of copper in order to prevent case rupture. This development was coupled with a new dry bullet finish which was named SILVADRY. Because of the requirement for retaining standard velocity loadings in the product line for the people who wanted them, or the older guns that could not handle the higher pressures, both the high speed and the standard velocity loadings were available in both lead lubricated and Silvadry bullet finishes. Thus, we have a need for 4 different sections for the 1930 Kleanbore issues, with this being the 4th in the series.

The packaging used in these 1930 issues was basically the same as the 1926 dogbone issue updated to show the bullet finish and if a high velocity loading. The Silvadry bullet finish was never very popular and was replaced with the Kleankote bullet finish in 1936.

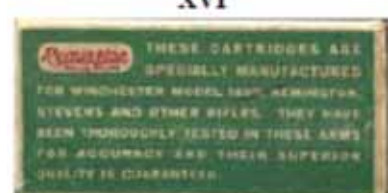

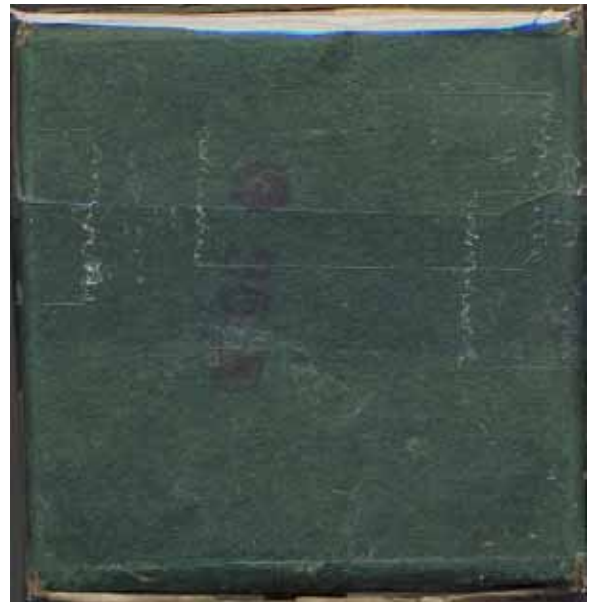

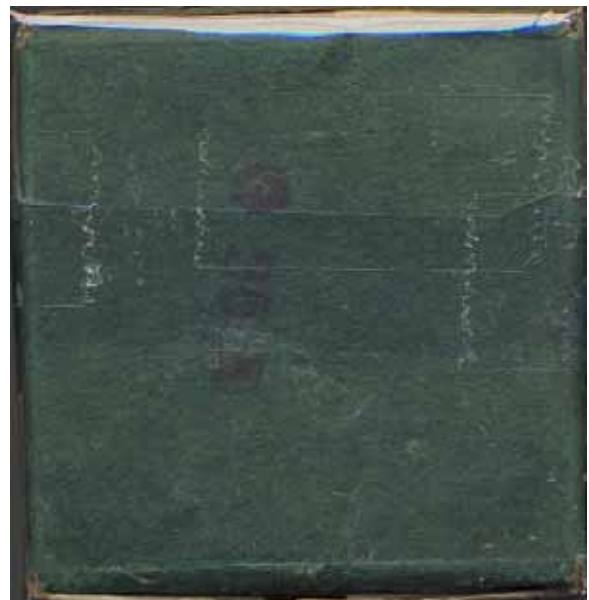

In 1936, Remington introduced a new bullet finish, which they named KLEANKOTE. This also called for a new style of packaging, replacing the dogbone Kleanbore issues. Remington never pushed a dry bullet finish because they feared it would cause excess bore wear. They felt they had a better dry lubrication with the KLEANKOTE concept. Dry bullet finishes prior to this coating caused problems, and most manufacturers dropped the metallic finishes from their product line after only a few years of sales. The metallic washing of lead bullets was reintroduced by most manufacturers after WW II, but this was generally combined with a wax type lubrication and the metallic finish was only for cosmetics.

The KLEANKOTE bullets were coated with paraffin. This was a process which was developed by Peters. They called it their FILMKOTE issues. Remington inherited this process when they purchased Peters in 1934. It seemed that this was a satisfactory solution to the bore wear problem. However, it must not have worked out as well as planned.

For whatever reason, the KLEANKOTE finish was not cataloged in the 1949 price sheet. This would make this a four or five years of sales issue. They are somewhat difficult for the collector to locate at this time. The W.R.F. loadings do not have the Kleankote name and may be considered as a separate issue.

The STANDARD VELOCITY is printed on white cardboard and the HI-SPEED is printed on yellow cardboard except some of the HI-SPEED WRF R28S boxes were printed on white cardboard.

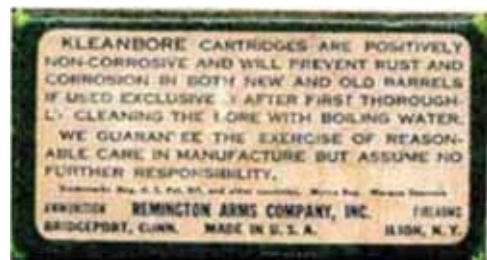

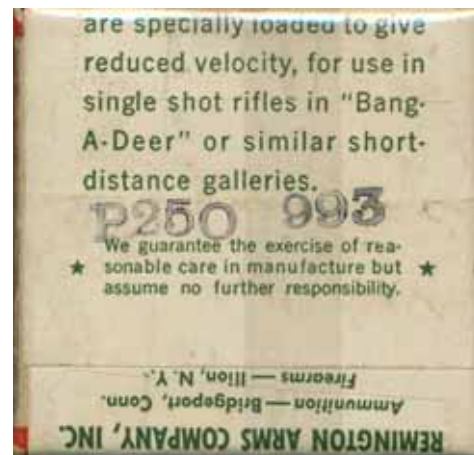
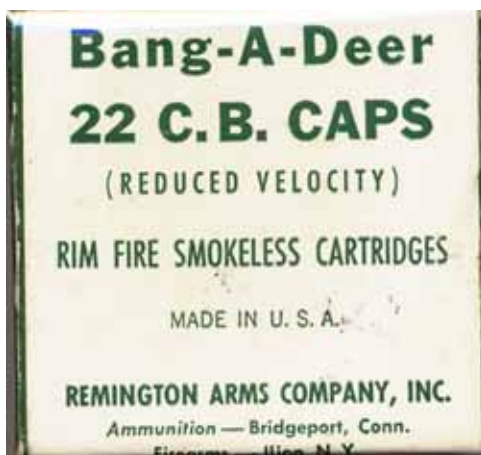

The standard velocity loadings remained in the line without great change until 1962. The medium velocity loadings seemed to have been dropped by 1950. The high speed loadings remained in the line until the late 1950's.

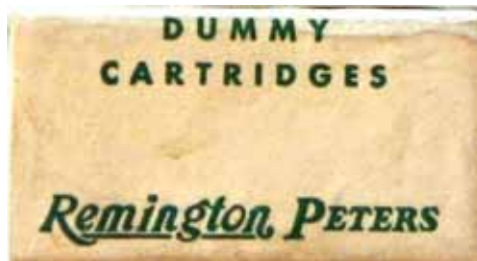
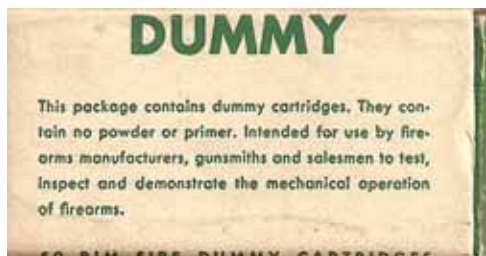
